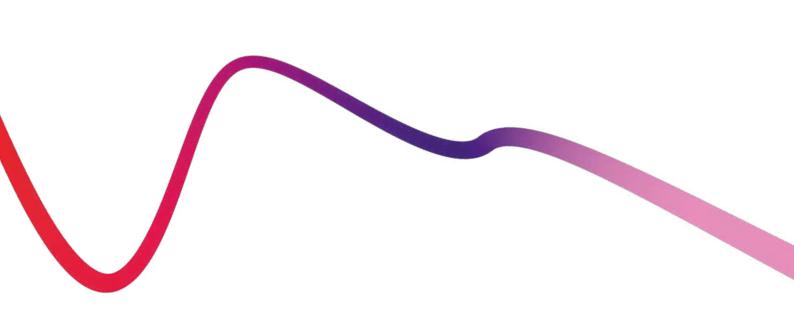

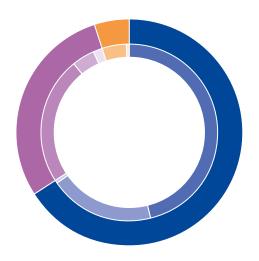

The energy group MVV Energie CZ is among the leading producers and distributors of heat in the Czech Republic. Through fifteen companies, it produced and supplied 692 thousand MWh of heat and 171 thousand MWh of electricity to customers in fifteen cities in the last fiscal year. Customers include 70 thousand households and 700 companies, organizations or industrial sites. It offers its almost 500 employees interesting and stable jobs in the regions.

The Group also deals with combined heat and power generation, environmentally friendly waste-to-energy, energy consulting, water management and the provision of electronic communications services. It has been providing energy services since 1993 – in the Czech Republic it is one of the most significant and longest-running suppliers of so-called Energy Performance Contracting (EPC). Almost 180 modernized buildings bring their owners or operators guaranteed savings of more than CZK 1.1 billion.

It is the emphasis on modern energy, efficient production and greening that is decisive for all MVV activities. This is evidenced by, for example, the GreenNet projects in Liberec and Pelhřimov, or the geothermal source in Děčín, followed by innovative projects in Litoměřice and other cities.

The Group's parent company is MVV Energie CZ a.s., which was established in October 1993. Since 1999 the company has been a subsidiary of MVV Energie AG, a German energy group, based in Mannheim, Germany.

It would probably be appropriate to start by analyzing the results. However, there are a number of chapters and contributions in this annual report devoted to these. Therefore, I would like to begin by mentioning the factor

that affected our entire Group, our customers, in fact the whole world.

Yes, it's covid-19. The first wave in the spring of 2020 was a challenging test for us. Not only with regard to the immediate effects of the pandemic on the health of our employees or customers, but also on our operation itself.

Thanks to the considerable efforts of all our teams, we managed to maintain complete operation of both production and distribution. Despite the negative impact of around 10% EBIT, I highly value and appreciate the team work and flexible management of individual operations.

Without coal by 2028

As I and my colleagues mentioned in the previous annual report, our long-term priorities – with tangible results – are measures for innovation and decarbonisation. We want to move away from coal by 2028, in full compliance with the State's carbon neutrality policy, and the pan-European commitment to climate protection. Currently, this fuel makes up only 14% of our mix.

I have no doubt that the so-called Green Deal will result in a positive change in the domestic energy market. Even now, Czech consumers already feel that climate protection is not free. We have been registering much higher fuel costs and dramatically rising gas prices on many fronts since the summer of 2021. The energy environment is also affected by the prices of emission allowances, which have doubled during the year and continue to rise sharply. It is a demanding period for all of us – manufacturers, distributors and, of course, customers. But I believe that the situation will gradually calm down, aided by financial compensation from the Czech government for the most affected households.

At the same time, domestic customers are already accustomed to the fact that the carbon footprint is reflected in practically all activities and products. And energy is not and cannot be cheap. However, the more we avoid CO₂, think responsibly, reject coal and look for innovative solutions and consumption savings, the easier it will be to switch to renewable energy sources (RES).

Green services on the rise

Sometimes I feel that the theme of ecology is a numbers game. I welcome the fact that Czechia wants to reduce CO₂ emissions by 60% by 2050 compared to 1990. However, I cannote explain the extension of landfilling until 2030. In addition to the indisputable impacts on the environment, this postpones the possibility of the ecological and efficient conversion of non-recyclable waste into heat and power.

For us, it is an impulse for further innovation. For example, we now offer a service for developers aptly called Develore,

which concerns the local distribution network and in principle community energy with the involvement of RES.

That is why we are investing in the establishment of charging stations for electric cars in Liberec and Vsetín, and that is why we have installed a new gas boiler in Litoměřice and also why we are building a new wastewater treatment plant in Studénka in accordance with current environmental protection regulations.

At the same time, we are focusing on economical operation and lower consumption of existing and new customers. Our energy services division has this directly in its job description. Its team for "EPC by MVV" is powerfully strengthening in terms of personnel and technology. This is not only on the basis of excellent recent results, but also with regard to the number of expected tenders. After all, we are the winner of the very first tender for an organizational unit of the state – specifically the District Court in Pilsen!

Last but not least, we are preparing to enter the market of ancillary services. This is the provision of power balance services for the Czech Transmission System (ČEPS). Details of this ambitious plan, thanks to which we will capitalize on our investments in cogeneration units, will be announced next year. I can mention that the pilot projects concern our facilities in Česká Lípa and Děčín.

Care first

Few of our current and developed activities would succeed if we could not find partners for them in local governments, housing cooperatives and associations of unit owners and, of course, customers. Not to mention the active approach of people from the entire MVV group.

Therefore, for the past period, I would like to highlight the results of our latest surveys among customers and employees. In both cases, we have received the best ratings in recent years.

We also took advantage of a number of beneficial suggestions: for example, we have installed a client CRM system that significantly simplifies communication and data sharing. We have strengthened the business team of district heating and electricity specialists who care for tens of thousands of customers in the regions.

With regard to all of the above and more, I would like to warmly thank all my colleagues for their excellent cooperation in another absolutely exceptional year.



A hary



In MVV without coal by 2028

New technologies and modernization measures in the field of energy bring higher efficiency, lower consumption, and continuous reduction of environmental impacts. The MVV group also continued in the period 2020–2021, in close cooperation in all cases with local governments and the customers themselves.

Biomass, gas, geothermal energy, or municipal waste that cannot be recycled. These are all sources that are replacing coal in the MVV group's fuel mix. In the remaining localities where coal appears, there has been or will be a significant greening of operations. And this fuel will be eliminated completely by 2028.

We rely similarly on renewable energy sources, especially solar energy. Their availability, expansion and increasingly efficient operation are enhanced by rapid technological innovations, the possibility of accumulation, or software tools for adapting supply to demand. All lead to a balance network

This category also includes investments in charging stations for electric vehicles, which our Group installed in 2021 in Liberes and Vestin

Effective regions

For local communities, MVV group companies are developing opportunities to use solar energy. In Česká Lípa and Děčín, pilot projects for the provision of power balance services for the Czech Transmission System (ČEPS) began in the period under review, with the involvement of smaller energy-efficient sources – cogeneration units.

We do not only focus on energy equipment, but also on transmission systems. To significantly reduce losses in heat supply, 450 meters of modern hot water pipeline were installed in the Trávníky housing estate in Vsetín. The investment-intensive revitalization of distribution systems will continue in the next period.

Cleaner Litoměřice

In Litoměřice, our subsidiary ENERGIE Holding partially swit ched from coal to biomass last year. At the end of June 2021, it also ceremonially put into operation a new Bosch UNIMAT UT-M 34 × 16 gas hot water boiler with a minimum efficiency of 95.5%, with low noise and a unique minimization of flue gas emissions. The facility thus contributed to the efficient supply of cleaner heat to thousands of households, the local hospital, and many companies in the city.

The new technology serves to cover daily peaks, and also as a backup source for the existing heating plant. It represents a significant investment in the city's future energy mix. And if the results of preliminary calculations and surveys are confirmed, the local geothermal source will be too. In this respect, Litoměřice is a model for many other cities and regions.

Participation in Uherské Hradiště

The modernization of the coal-fired heating plant in Uherské Hradiště, operated by our subsidiary CTZ, is entering the final phase of fuel and technology selection. Decarbonisation of the heating plant will reduce greenhouse gas emissions and increase the overall quality of life in the city.

An expert study from the Brno University of Technology identified the combination of natural gas combustion in boilers and cogeneration units and municipal waste incineration in a waste-to-energy plant as the most advantageous variant of modernization.



A pivotal year for EPC

Several significant orders in the field of Energy Performance Contracting (EPC) were taken by the Energy Services Division in the past period. It is notable that the MVV group was the first in the field of EPC to succeed in a tender for an organizational unit of the state – specifically the savings project for the District Court in Pilsen.

Under the leadership of Martin Hvozda, the Energy Services Division was also successful at a time when the EPC market was marked by the pandemic. Notable achievements of his department in the Ústí na Labem Region, in addition to contracts for the Region itself or the J. E. Purkyně University, included signing a project for the town of Chabařovice with an investment of 15 million Czech crowns.

MVV the first supplier for an organizational unit of the state

The EPC project for the District Court in Pilsen was a great success, which was preceded by a long preparation and helped by positive references so far. This is the very first such project for an organizational unit of the state, which is a harbinger of further tenders at the level of state administration.

According to Martin Hvozda, the renovation of buildings belonging to the state sector will require massive investments. The EPC method is a suitable tool to reduce their energy demands, and thus, among other things, to help reduce CO₂ production.

MVV is investing 9 million crowns in the modernization of the energy system of the district court, while the invested amount will be repaid from future savings, 27% for heat and 18% for electricity respectively.

Regional successes

Simultaneously with the successful EPC project in the Pardubice Region, a period of guaranteed savings for the Ústí Region also began in January 2021. This was a very complicated implementation in four regional organizations and a total of ten buildings with different types of operation. The total investment reached 51 million crowns.

The contract for the North Bohemian town of Chabařovice is smaller, but no less complex. The energy services division is modernizing the energy system, electrical installations, a gas boiler room for 15 million crowns, as well as light sources in three buildings and public lighting. We guarantee the amount of savings for a period of 12 years.

Phase of expansion

In the period under review, the Energy Services Division further expanded: in terms of personnel, territory, and range of services. In addition to EPC, it focuses on modern energy supplies – Energy Contracting. Thanks to their successful acquisition, it was possible to deal with the shortage of orders caused on the part of the issuers by restrictions related to the pandemic.

Even by the summer, the cumulative volume of projects amounted to 30 million crowns. And it has continued to grow. The EPC by MVV team is actively preparing for a number of new demands associated with new subsidy schemes aimed at energy savings – e.g. OPŽP, OPPIK or MPO-Efekt. In addition to the implementation itself, MVV also provides grant and professional advice.



Develore: a new service for developers and investors

The first project of the MVV innovation team for developers is the Develore product. It responds to current trends in the development of residential and commercial real estate. It finances and implements smart energy solutions, and at the same time offers direct capital input into development projects.

Develore is a service filling a gap in the market. It takes the usual supply of energy equipment or financial services to the next level. The essence of Develore is a long-term partnership with developers, which saves the initial investment associated with the energy solution. And, in selected cases, for MVV it also means the possibility of mezzanine financing, lowering the capital threshold for developers.

Smart and economical

Develore responds to the growing demand for smart technologies, savings and renewable energy sources. In this new service, energy solutions are tailor-made and designed: for sets of building plots and apartment buildings, older residential units, as well as entire new districts, office buildings or retail parks.

Develore thus deals not only with project preparation, but also the actual implementation and subsequent management and servicing of energy units. Modern low-emission technologies are preferred, such as gas cogeneration units or photovoltaic power plants.

All technology is financed by MVV. Investments are repaid from future operations at the level of end owners or tenants. Like the savings on initial investment, this is received very positively by developers. The product is also intended for real estate investors, housing cooperatives, or municipalities planning construction projects.

Closer to developers

The MVV group is also ready to support selected projects with capital injections. This is so-called mezzanine financing, which helps developers (investors) to obtain a bank loan with their own resources. However, capital input is not a condition for the implementation of an energy solution. It is a complement, conserving the developer's own resources.

MVV's stability, 25 years of experience in the field of Energy Contracting, and flexible settings to meet the stricter energy performance conditions of Develore buildings, make it a highly attractive product.





Surveys: reward and inspiration

We have recorded the best ever results from customers in an extensive survey conducted in 2020. A questionnaire survey among employees also had a positive outcome.

MVV group, and its subsidiaries, is a reliable heat supplier deserving of recommendation. These are the main conclusions of an extensive survey conducted by a specialized agency among owners associations and housing cooperatives, local governments and corporate customers.

Surpassing our results

Results also exceeded expectations in other categories, such as communication, responsiveness, speed of repairs, handling requests, and also social responsibility. In many areas, we have gone beyond so-called benchmark values, which compare the perception of our Group with its competitors.

Thanks to the responses received, we immediately turned our attention to areas with lower satisfaction or specific complaints. As there were only a handful of such cases, we implemented the measures very quickly.

Incentives for growth

According to Jan Vencour, Director of the Capital Participation Department, in charge of satisfaction surveys, the results reflect increased customer care. Despite the best rating in history, the survey provided several suggestions for new services or products.

Through them, we will respond to the activities of competitors, and in several cases this is already happening. The goal is to further support our positive perception and become the first choice as a supplier of heat and electricity in the long run, not only in the context of central sources, but also separate gas or cogeneration boilers. Loyalty programs or new client (CRM) systems in many places where we operate will also help.

Stronger together through circumstances

Immediately after the first wave of the covid pandemic, another survey took place, this time among employees across the entire group. This also showed a positive trend. Not just qualitatively, where 87% of the members of our team are very or rather satisfied, but also in participation, as for several subsidiaries this reached 100%, testifying to the importance and effectiveness of such activities.

In addition to feedback, we also received valuable impulses to improve working conditions. Often mentioned was, for example, the possibility of working from home (home office), which the Group companies approached in connection with the pandemic, wherever possible.

What the survey revealed?

- The highest satisfaction among associations of unit owners / cooperatives with heat supply is in Uherské Hradiště.
- The largest increase in satisfaction among associations of unit owners / cooperatives occurred in Opava, Louny and Česká Lípa.
- The most significant increase in satisfaction with companies is in Uherské Hradiště, Litoměřice and Děčín.
- The highest average rate of supplier recommendation by associations of unit owners / cooperatives is in Uherské Hradiště.
- The highest average recommendation rate by corporate customers is in Děčín, Česká Lípa and Uherské Hradiště.

Company profile

History of the company

MVV Energie CZ a.s. was established on 6 October 1993. The main line of business of the company, formerly operating under the name EPS ČR s.r.o., was the provision of energy-related services. The company's original majority owner was the US-based Energy Performance Services Inc.

In 1999 the German company MVV Energie AG, one of the largest energy companies in Europe, purchased a majority stake. In the subsequent years it has managed to develop a large energy group in the Czech Republic, which today operates in fifteen cities throughout the country. MVV Energie CZ a.s. is wholly owned by MVV Energie AG.

Activities of the company

MVV Energie CZ group companies operate mainly in the field of heat generation and distribution. The Group also produces electricity in eleven cities of the Czech Republic. In addition, some of its subsidiaries provide water management or electronic communications services as well as other services.

MVV Energie CZ a.s. has extensive experience with the implementation of energy-efficiency projects in the Czech Republic. In addition to projects employing EPC (Energy Performance Contracting), it also offers related energy services to customers across the country.

Energy generation

To generate heat MVV Energie CZ group uses a fuel mix whose dominant component is natural gas. The Group generates electricity only by cogeneration, that is, through combined heat and power generation. Twenty sites in eleven cities use cogeneration engines or turbines, with a total capacity of almost 52.86 MWe, to cogenerate electricity and heat.

MVV Energie CZ group is the only operator in the Czech Republic to utilize geothermal water to generate heat, for thousands of households in Děčín. This geothermal source, which has brought significant improvements to the environment in the entire region, won the Project

of the Decade award (a competition organized by the Association for District Heating of the Czech Republic) for systems supplying heat and cooling.

In 2011 MVV Energie CZ group entered the waste-to-energy business. In the Liberec region, MVV Energie CZ uses more than half of all the waste produced, which would otherwise end up in landfills, to generate heat and electricity.

Customers of MVV Energie CZ

Our customers in fifteen cities across the Czech Republic are households, small and large companies and municipalities. In 2020–2021, the MVV Energie CZ Group sold 692 thousand MWh of heat and 171 thousand MWh of electricity, and its turnover in the financial year was CZK 2.1 billion.

People in the company

The statutory body of MVV Energie CZ a.s. is its Board of Directors, which is comprised of two members. The head of the company is Jörg Lüdorf, the Chairman of the Board of Directors, responsible for strategy, trade, technology, energy services, and the management of all shareholdings. The second member of the Board of Directors, responsible for finance and information technologies is Jaroslav Pantůček.

MVV Energie CZ a.s. has 46 employees in total.* The company comprises individual departments supervised by directors and two divisions, with some employees reporting directly to the Board of Directors.

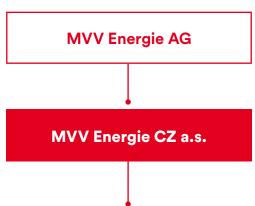

Major events in 2020-2021

CTZ in Uherské Hradiště celebrated its 25th anniversary

More than 5,000 households, city buildings and industrial buildings in Uherské Hradiště have been supplied with heat and hot water by CTZ s.r.o. for 25 years. Since 2009, electricity has also been added to supplies. With its anniversary of March 2021, CTZ underlined its results in the Group customer survey: in 2020, CTZ performed best among all MVV Group companies. Thanks to exemplary care, innovations, communication and other, often socially responsible, activities, it manages to constantly increase the number of customers. An example of successful management is the Vision of the Smart Q.City project, with four apartment buildings connected to a newly built local distribution system with its own cogeneration unit.





The Vision Smart House project in Pelhřimov has been launched

The owners of 106 apartments in the architecturally successful LiveWell residential district in Pelhřimov are already taking full advantage of the Vision Smart House project. IROMEZ supplies heat and electricity to residential units and non-residential premises within the local distribution system. During the most significant investment project of the last two years, the company installed a cogeneration unit, and hot water and electrical connections to all buildings. In addition to smart meters, users have a perfect overview of consumption and costs. It is on the Vision Smart House projects that the MVV online mobile application is already working successfully.

Smart view on energy – thanks to our new application

It is not just in Pelhřimov that customers have access to energy data from anywhere and at any time. This new benefit in the Vision Smart House projects is also available to customers in the new Q.City residential district in Uherské Hradiště and in Kylešovice in Opava. In addition to quick access to energy consumption data, the MVV online application offers a range of other useful information. Everything is processed clearly, simply, with access to archiving and basic analysis, in both Android and iOS operating systems. Progressively, other partners and customers will be able to use the MVV online application.





We presented projects and a new boiler room in Litoměřice to our visitor from Mannheim

The ambitious plan for faster decarbonisation of our energy facilities was officially presented in November 2019. Ralf Klöpfer, Chairman of the Supervisory Board of MVV Energie CZ a.s., came from the parent company MVV in Mannheim in August 2021 to inform himself about its fulfilment. In addition to current and planned projects, the management of the Czech group showed him a biomass boiler in the central heating plant and a new gas boiler, both operated by our subsidiary ENERGIE Holding in Litoměřice.

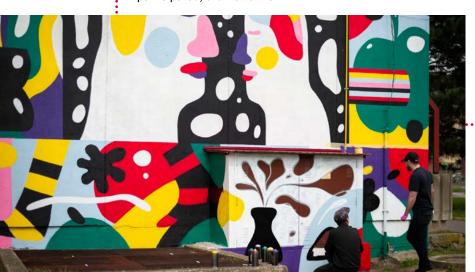


GreenNet in Liberec won the Crystal Chimney award

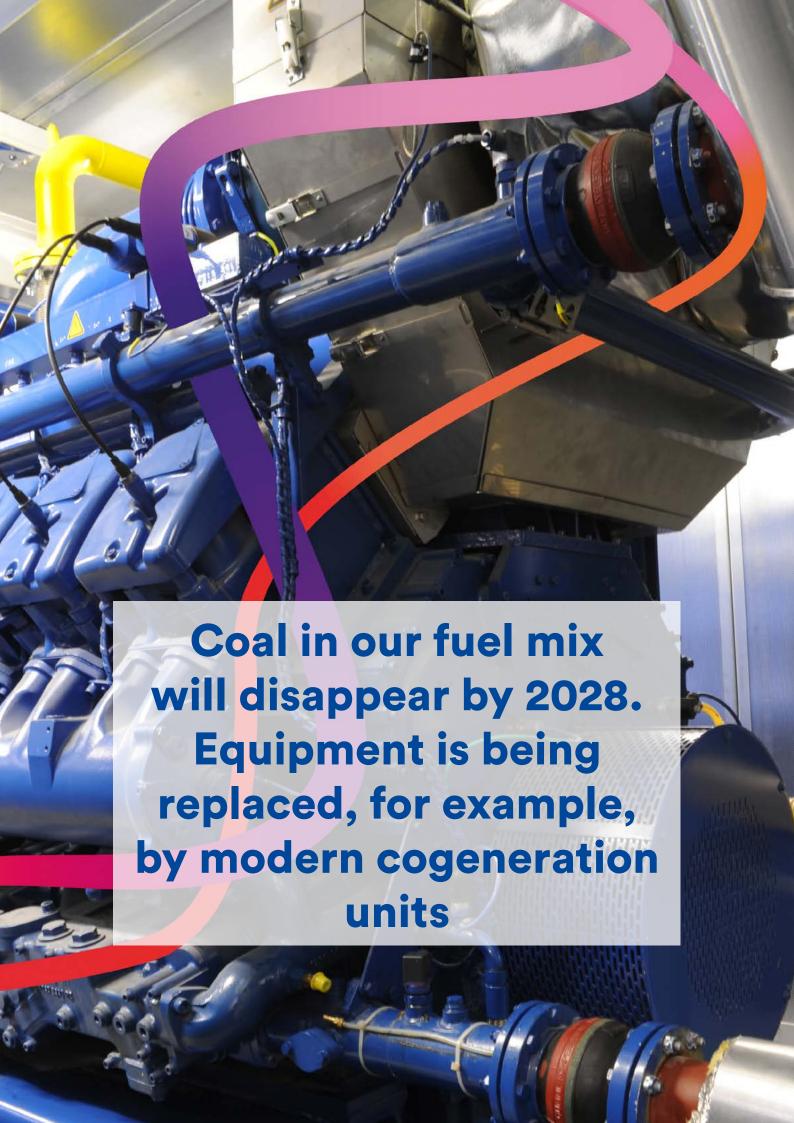
Our GreenNet projects are thriving. Our Group implemented them in two cities: in Pelhřimov, it replaced the steam pipeline with a more efficient heated-water pipeline, and in Liberec with a hot-water pipeline. In 2019, GreenNet in Pelhřimov received the Business Project of the Year award in the category of Energy Savings from Renewable Sources. The award is announced annually by the Ministry of Industry and Trade of the Czech Republic. In September 2021, this success was followed by GreenNet in Liberec, which the Heating Association of the Czech Republic awarded with the prestigious Crystal Chimney. The three million project was the largest investment project of Teplárna Liberec, which received a subsidy from OPPIK in the amount of 70 million crowns. The heating plant replaced and partially deepened 9.7 km of hot water pipelines, reconstructed 29 exchanger stations, and put into operation a new exchanger station with an output of 40 MW, and a cogeneration unit with an output of 1 MW. Savings converted to primary energy exceed 87,000 GJ.

The success of the EPC can be seen immediately

A separate chapter in the introduction to the Annual Report is devoted to the implemented, ongoing, and planned projects of the MVV Energy Services Division. In the monitored period, two events connected with the EPC project for the Jan Evangelista Purkyně University in Ústí nad Labem attracted the attention of the media and social networks. First, the highest available 40-meter platform in the Czech Republic had to be used when installing a new flue gas path on university dormitories for a cogeneration unit. Subsequently, the street art decoration of the new main gas valve, in which local artists participated, drew attention.







At the Share Your Energy conference, we introduced power balance services

Experts from the MVV group regularly participate and present at professional meetings. They are also active on our social networks, such as LinkedIn or Facebook. In June 2021, an inspiring Share Your Energy conference was held under the direction of Nano Energies. We were there too – Jan Sulík from ČESKOLIPSKÁ TEPLÁRENSKÁ shared his experience. At the conference, he presented a pilot project to provide performance balance support services – in other words, flexibility aggregation. This concerns the provision of ancillary services from cogeneration units, in this case an aggregation unit with an output of 10 MW, based on the strict certification conditions of the Czech Transmission System (ČEPS). During the Share Your Energy event, 20 speakers were watched by over 700 registered listeners.



In Vsetín, we reconstructed the backbone heat distribution

The long-term investment project of the company Zásobování teplem Vsetín continued with the complete replacement of the hot water pipeline in the summer of 2021. During the II. stage, the original pipeline with a total length of 426 m was replaced by a new, preinsulated pipeline. The inhabitants of the Trávníky housing estate, which we supply with heat and hot water, thus obtained a modern distribution system guaranteeing a minimum of forced outages or failures. The whole event, during which, among other things, new fittings were installed, shafts were modified, and other cables were laid, took place without the slightest complication. To the satisfaction of customers, it was completed before the deadline.



Our care for rare birds remains exemplary

Falcons have become an integral part of the chimneys of many of our heating plants. In the nesting season of 2021, the MVV group supported these birds of prey, either by installing new or renovating existing special booths – specifically, this care for the falcon's nesting grounds was applied in TERMO Děčín and ENERGIE Holding complexes in Litoměřice. These endangered birds received further support from our heating plants in Liberec and Uherské Hradiště. The ornithological project was further expanded in the latest period in Uherské Hradiště – CTZ placed special booths on its buildings, tailor-made for another bird species – swifts. The so-called swift-houses are supposed to partially replace their nesting in openings and crevices on the facades.

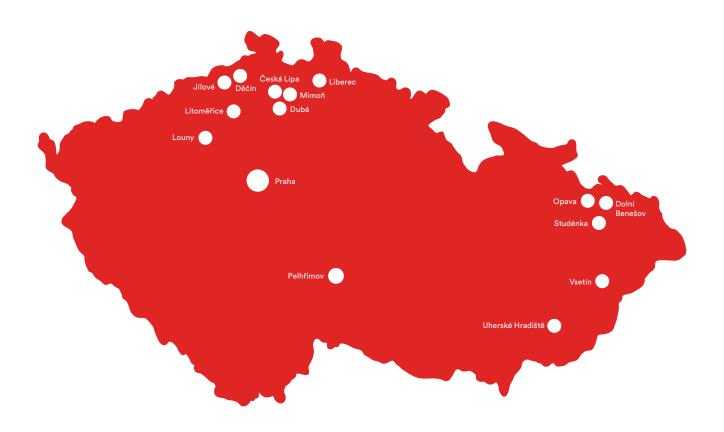


Our team spirit was strengthened by sports games and year-round webinars

The company CZT s.r.o. was founded by the town of Uherské Hradiště on 1 March 1996. Since 12 December 2000, CTZ s.r.o. has been a subsidiary of MVV Energie CZ a.s., which purchased a 50.96% stake in the business from the town. CTZ s.r.o. supplies heat energy and hot water to households, industrial entities and customers from the tertiary sector in the town of Uherské Hradiště. It has also been an electricity producer since 2009. The electricity, produced by a steam back-pressure turbine, is partly used for own needs, or is supplied to the distribution network. Since 2019, the company has been a local supplier of electricity to the apartment buildings in the Q.City residence.

The most significant investment project in the 2020–2021 financial year was the installation of a co-generation unit for gaseous fuels in the existing block boiler room in Štěpnice, associated with the construction of a new chimney body and a new transformer station. This project followed the installation of a gas boiler, which took place in the previous fiscal year. By implementing the project, the company has increased the production of electricity and the capacity of gas sources, while reducing emissions and the energy consumption needed to produce the required amount of heat. The company received a grant for the project from the Operational Enterprise and Innovation for Competitiveness Programme.

The technology for ash misting on the coal boilers of the coal boiler room in CTZ – Mařatice was commissioned for operation, which will help to operationally optimise the discharge of the ash mixture with the products of desulphurisation, slag, and water from the coal boilers.

As part of network investments, CTZ installed sectional closures in the backbone hot water junction near the ice hockey stadium.

CTZ has long managed to maintain a stable customer portfolio and connect new apartment buildings. In the past fiscal year, the company connected a new multifunctional building, Hradební, and the Nové Štěpnice apartment building, to the central system. For Rezidence TŘIDOMY in the Sady area, CTZ have started work on connecting the apartment buildings to the heat and electricity supply.

During the year, the company continued the modernisation of the Mařatice heating plant. The heating plant will transition to another fuel or a fuel mix, which will replace the existing coal. For this purpose, the company commissioned an expert study at the Brno University of Technology, which assessed several solution variants and combinations, particularly from an economic and environmental point of view. The results of the study were presented to representatives of the town of Uherské Hradiště, journalists and the public. CTZ also co-organised round table public discussions. The shareholders will decide on the final variant replacing coal combustion in the next fiscal year.

In connection with the pandemic, when mass events were restricted, the company focused on financial support. It supported three major projects: a project to attract first-time blood donors, a charity event to attract bone marrow donors, and the international "Living Cities" project, where the company placed special "swift house" birdhouses in its boiler rooms. Furthermore, the company supported the Uherské Hradiště Regional Charity, the PAHOP Medical Institute of Palliative and Hospice Care, the 1. FC SLOVÁC-KO football club, the water park and the theatre Slovácké divadlo.

ENERGIE Holding a.s. mainly supplies heat to households and the tertiary sector in Litoměřice, Louny and Mimoň. It is also a producer of electricity in Mimoň.

Replacing coal in the fuel mix is a medium-term goal of ENERGIE Holding. As part of the modernisation of heat sources in Litoměřice, the new gas boiler room with an exchanger station in Havlíčková Street was equipped with a Bosch gas hot water boiler, which serves as a backup for the existing heating plant, and is a unique minimisation of emissions. It also carried out reconstruction of the flue gas paths and modification of the belt transport of fuel for the K2 and K3 boilers. The company also renovated another section of the heat distribution in Jungmannova Street and completed renovation of the exchanger at the EC5 Litoměřice station.

In connection with the transition to biomass combustion in the Litoměřice and Mimoň areas, the company built new facilities this year to weigh the amount of fuel supplied and to evaluate fuel efficiency.

In all three locations, ENERGIE Holding continued replacing heat meters with the possibility of remote radio reading, thanks to which it will no longer be necessary to enter the heated buildings for measurements.

The company introduced a new product for customers – the installation of photovoltaic systems on the roofs of prefabricated houses. Customers can thus generate their own electricity, saving dozens of per cent in costs.

This year, the company supported the Mimoň Social Services in the retirement home. It participated in the Environment Day event, organised by the city of Litoměřice for the general public, and supported the Ohře rowing club in Louny. It made a financial gift of a social car to the Centre for Disabled Children and Youth – SRDÍČKO in Litoměřice.

IROMEZ s.r.o. is the operator of the district heating system in Pelhřimov. It was founded in 1992, when it bought heat management from the town of Pelhřimov. It became part of the MVV Group in November 2009.

Thermal and electrical energy is produced here using cogeneration with biomass combustion. 99.7% of the fuel base is forest wood chips processed with own technology. Natural gas boilers are used as backup sources. IROMEZ in Pelhřimov supplies heat to households, schools, kindergartens and buildings of the city and the business sector.

The most significant investment project of the last two years was the Vision Smart House project in Pelhřimov, which was completed at the end of the 2021 fiscal year. The project involved the installation of a co-generation unit and the construction of hot water and electrical connections for the new apartments in the LIVEWELL residence, for which IROMEZ will be the local supplier of heat and electricity. The LIVEWELL residence includes 106 modern residential units, including large non-residential premises. After a trouble-free test run, the co-generation unit is now operating normally.

As in previous years, the company invested in fleet renewal and equipment for the production of forest biomass.

IROMEZ has a long-term stable customer structure. Customers appreciate both the loyalty programme with advantageous conditions and the worry-free, comfortable energy supply.

The company is also dedicated to the provision of additional services to the customers and wider general public of Pelhřimov. This includes the sale of briquettes and pellets, and the operation of its own petrol station, which offers loyalty discounts to heating plant customers.

The construction of the heating plant in Liberec was completed in 1976. After its expansion in 1995, the joint stock company Teplárna Liberec was founded by Severočeské teplárny, a.s. and the city of Liberec. A change in the shareholder structure took place on 4 January 2007, when ENERGIE Holding a.s., the legal successor of United Energy, bought 70% of the shares. Teplárna Liberec thus became a member of the MVV Energie CZ Group. The remaining 30% stake remained in the ownership of the Statutory city of Liberec. The latest change of shareholdings occurred on 14 February 2018: ENERGIE Holding now owns 76.04% and SCL 23.96%. A new advisory body, called the GreenNet Committee, was established to support the modernization of the steam network.

The main business activities pursued by Teplárna Liberec are the generation, distribution, purchase and sale of heat and electric power, as well as the sale of natural gas. The company supplies thermal energy to the city of Liberec and Vratislavice nad Nisou, a municipal district of the city of Liberec. It supplies electricity and natural gas to the TERMIZO plant for energy-efficient use of municipal waste. These plants are operationally connected, and the thermal energy purchased from TERMIZO is used to supply the majority of Liberec city.

In the 2020–2021 financial year, the company successfully completed an extensive GreenNet project, which involved replacing one of the steam pipeline branches with a hot water pipeline and renovating the heating network in Pavlovice. On 14 September 2021, it received the prestigious "Project of the Year" award for this project from the Heating Association of the Czech Republic in the "Reduction of heat losses, transition to more efficient hot water distribution" category.

The company acquired and commissioned a new K11 boiler. After purchasing a new co-generation unit, the equipment installation started. It completed work on the hot water connections of the second stage of the Kladenská Apartment Buildings and the Labour Office in Liberec and started heat supplies. In the Gagarinova housing estate, it implemented a new connection for the Hvězdička nursery, which was approved the following year, and carried out regular maintenance and renovation of the chimney, during which it renovated the exterior cladding and paint.

During the year, the heating plant worked on repairing equipment, especially in the primary and secondary distribution systems. Technicians made several minor repairs and adjustments throughout the heating network that can only be carried out outside the heating period.

In customer care, this year the company focused on offering to extend the contracts of the loyalty programme, which it launched in 2016. Thanks to favourable conditions, customers can save energy costs.

Teplárna Liberec also participated in educational, cultural and sports projects this year. For example, in parallel competitions, it supported the Warsaw Cinema and the Vratislavice nad Nisou Library. It also supported the Jizera-Ještěd Mountain Association and in June 2021 organised a professional lecture at Sokolovská Primary School.

TERMIZO's largest investment projects in the 2020–2021 financial year included an increase in the output of TG Siemens and the intensification of condensate management to maintain the stable performance of TG Spilling. With regard to the fulfilment of legislative emission requirements, the company installed ammonia measurement and replaced evaporator 1 as part of repairs to the pressure unit. It also carried out extensive repairs to the waste hopper, flue gas scrubber and the 3rd section of the electrostatic precipitator. It paid great attention to refractory linings. The changes and investments made will continue to ensure the efficient operation of the facility and compliance with all emission limits.

TERMO Děčín a.s. was established by the city of Děčín in 1995. In May 2000, MVV Energie CZ a.s. became its strategic partner. Since August 2005 MVV Energie CZ has had a 96.91% share in TERMO Děčín, with the Statutory city of Děčín retaining a share of 3.09%.

TERMO Děčín is the main supplier of heat and hot water in the towns of Děčín and Jílové, and uses gas and geothermal water as sources. In the Czech Republic, this represents a unique system of central distribution of heat. In 2012, the geothermal-powered central heat generator in Benešovská street won the Project of the Decade award in a survey of professional journalists organised by the Association for District Heating of the CR.

TERMO Děčín supplies heat from five central heat sources, one block boiler and sixteen residential gas boiler rooms.

The company runs a loyalty programme for customers, through which, thanks to long-term contracts, they can benefit from the comfort of a comprehensive service with advantageous terms and conditions.

In 2020–2021, TERMO Děčín implemented significant projects focused mainly on the renovation of equipment for the production of heat and electricity. As part of these investment projects, the company replaced the control systems of the M1 and M2 co-generation units at CZT Železnice and CZT Benešovská, respectively. Furthermore, it replaced the flue gas coolers in order to achieve higher operational efficiency in the M2 co-generation unit in CZT Benešovská.

In the area of distribution at CZT Benešovská, the company replaced the circulating pump frequency converters for thermal energy. In the case of electricity, in order to increase the CHP operational efficiency at CZT Želenice and CZT Bynov, preparations were made to start the provision of distribution network power balance services in cooperation with (aggregator) PRE, a.s. These investments will further ensure the safe and reliable operation of the entire heat distribution system, and reduce the environmental burden on the Děčín region.

The company offered customers from Děčín the product "Clean Heat and Light" for Děčín. This project is based on the supply of the electricity that TERMO Děčín produces at its central sources, or combines the supply of thermal energy and production of electricity from a photovoltaic power plant.

The goal is to provide customers with a new product that generates up to tens of percent of savings in electricity costs. One part of this product is the distribution and sale of power as a commodity. The other part is the installation of photovoltaic systems on the roofs of prefab houses, thanks to which customers generate their own electricity and thus save on hot water heating costs.

Zásobování teplem Vsetín a.s. (ZTV) was founded by the National Property Fund of the Czech Republic in May 1992. Since March 2000, the company has been a member of the MVV Group. Since 18 August 2012, MVV Energie CZ a.s. owns 100% of the shares.

ZTV supplies heat to Vsetín and the Jasenice industrial estate. The main sources are the technologically-connected heating plants of Jiráskova and Ohrada, which, in addition to heat, also cogenerate electricity. In the Jasenice industrial area, the main heat source is the Jasenice coal heating plant.

It supplies electricity to end customers, local distribution systems, and partly to the regional system. It operates one block boiler and one residential boiler room. On the Jasenice industrial estate, it is engaged in water management and provides electronic communication services. It also supplies drinking water in Studénka, where it provides drainage and wastewater treatment as well.

In Vsetín – Trávníky, the company replaced over 400 m of the DN400 backbone hot water pipeline. In the Jasenice locality, it strengthened the heat exchanger for the renovated M5 hall, and at the same time the company installed two 1,000 kVA transformers for this hall, which will be used primarily to supply the new technology of the building owner. The K4 boiler was demolished in the Jiráskova heating plant, and construction is being prepared for two new gas co-generation units.

At the Jasenice and Studénka water management system, ZTV replaced sections of high frequency water supply system failures, and lined part of the sewerage section in Studénka. It completed project documentation for the reconstruction of the Studénka WWTP and launched a tender for the selection of a contractor. The new WWTP technology will increase the quality of treated wastewater discharged into the Odra watercourse.

A project for the construction of a waste-to-energy facility, prepared in cooperation with the parent company MVV Energie CZ a.s., was not supported either by the Vsetín public or town representatives. As a consequence, preparations were stopped. Only the environmental impact assessment process, taking place in October 2021, is being completed.

As in every year, in November 2020 the company organised a competition in Vsetín for children from nurseries which use district heat. The children playfully engaged with this year's theme, "Warm, warm, warm", and received prizes for their beautiful creations.

Additionally, the company financially supported the Wallachian Hockey Club, the Vsetín Volunteer Fire Brigade, the Vsetín Biathlon Club, the children's summer camp in Bystřička organised by the Alcedo leisure centre Vsetín, the Vsetín Climbing Section, the 20th year of the Starý Dobrý Western country festival, and the Integra Primary School, which used the financial gift to support contracted research to assess the school in the context of education in the Czech Republic.

Compliance

The Compliance Management System has been in operation in MVV Energie CZ a.s. since 1 October 2013. To ensure that the system operates smoothly, the company uses a structure of internal guidelines on the basis of which the rules are applied within the company.

The company's Compliance Management System includes in particular the following areas of activity:

- · economic competition,
- financial and tax matters,
- employee relations (including equal opportunities),
- data protection,
- occupational health and safety,
- environmental protection,
- combating corruption.

In order to comply with all the values mentioned above within the framework of the CMS, MVV Energie CZ group has a shared position of Compliance Manager, who provides for supervision over compliance with the CMS rules in all MVV Energie CZ group companies, including MVV Energie CZ a.s. At the same time, the Compliance Manager takes the necessary measures to remedy the situation if the rules are violated.

All employees of MVV Energie CZ a.s., as well as any other person, are entitled to report any actual or suspected breach of the obligations and guidelines contained in the CMS via a hotline set up as part of the CMS in MVV Energie CZ group, using the email address compliance@mvv.cz. The Compliance Manager is responsible for the operation of this hotline and for ensuring the confidentiality of communication and processing of each notification made via the hotline.

MVV Energie CZ a.s. may also utilize the existence of the Equal Treatment Manager and the Data Protection Manager positions, established as part of the CMS within the MVV Energie CZ group.

The Equal Treatment Manager supervises compliance with the fundamental principles and rules of equal treatment and protection against discrimination in all companies of the group, including MVV Energie CZ a.s., and supervises the settlement of notifications received with regards to potential breaches of the principles of equal treatment and protection against discrimination.

The Data Protection Manager's key responsibilities include supervision of compliance with the internal system of data protection and security of data during its processing in the MVV Energie CZ group in accordance with the Principles of Personal Data Processing of the MVV Energie CZ group, supervision of Compliance with the deployed internal systems, rules and regulations, and the settlement of notifications received with regard to potential breaches of data protection and the processing or unauthorized use thereof.

In accordance with the Principles of Personal Data Processing, all employees of MVV Energie CZ a.s., or any other person, are entitled to report any potential breach of responsibility or breach of personal data protection rules, or even suspicion of such breach, to the osobniudaje.mvv@mvv.cz email address, established in accordance with the Principles of Personal Data Processing. The Data Protection Manager is responsible for the operation of this email address and for ensuring the confidentiality of communication and processing of each notification received at this email address.

Board of Directors' report

on the business activities of the company for the fiscal year 2020–2021 (October 2020 – September 2021)

MVV Energie CZ a.s. operates in the energy sector, primarily in the provision of district heating. The main mission of the company is to manage ownership interests in subsidiaries, to provide selected services to subsidiaries and – outside the Group companies – to provide energy services, for example, using the EPC (Energy Performance Contracting) method, innovative activities such as Develore, or the Smart House Vision projects.

The core business of the subsidiaries is the generation and distribution of thermal energy, high-efficiency power cogeneration, and the operation of waste-to-energy facilities. For the whole year, the two-member Board of Directors of the company MVV Energie CZ a.s. comprised Jörg Lüdorf, Chairman of the Board of Directors, and Jaroslav Pantůček, member of the Board of Directors.

The focus of the Board of Directors is on the achievement of the planned financial results of MVV Energie CZ a.s. At the same time it also pursues objectives corresponding to the stated climate commitments of individual towns and municipalities. In many cases, it is also their initiator, as evidenced by the list of implemented or planned projects in the period under review.

At the close of the 2020–2021 fiscal year, MVV Energie CZ group generated a positive consolidated operating profit. Due to the fact that coal accounted for a seventh of the fuel mix, the Group was only minimally burdened by the purchase of emission allowances. Thanks to the appropriate composition of resources and the fuel mix, the financial results remained resilient despite the price of allowances increasing several times year-on-year. The somewhat negative effects of the pandemic were countered by a long heating season and at the same time the development of new services and business activities. There was an analogous situation with gas, whose prices began to rise rapidly at the turn of the fiscal year 2020–2021.

All companies in the Group strive for a minimum environmental footprint while providing their services. With thermal energy generation, this involves for example the use of suitable fuels (natural gas, geothermal, biomass) and combined heat and power generation (cogeneration), a process that maximises the efficiency of the fuel used. In 2020–2021, the Group also implemented a number of measures to increase efficiency, reduce heat loss, and renew resources as well as distribution networks.

The most important investment projects include a new gas hot water boiler in Litoměřice (ENERGIE Holding), installation of a modern hot water pipeline in the Trávníky housing estate in Vsetín (Zásobování teplem Vsetín), a new cogeneration unit in Liberec (Teplárna Liberec) or preparation for installation of new charging stations for electric cars in Liberec and Vsetín. At the same time, preparations continued for the extensive greening of the heating plant in Uherské Hradiště.

For MVV group, the supply of safe, high-quality energy, and a proactive approach to customers, remain its top priorities. Its energy supply package always includes reliable customer service and consultancy, round-the-clock emergency services from the control centre, and heat generation and distribution facility management. This approach was evident as a comfortable energy supply was ensured without interruption even in the exceptional situation of coronavirus restrictions from Autumn 2020 to Spring 2021.

During the 2020–2021 fiscal year, the Group continued its customer expectation survey, which gave it the insight needed to better listen to customers' needs, and enhance customer support. The Group also continued to develop its loyalty scheme, rewarding long-term contracts. Together with the cities in which the MVV Energie CZ group operates, it again participated in a number of social, sports and cultural projects.

MVV Energie CZ group also worked on services to employees, the professional development of personnel, and team-building activities. The inspiration for improving employee care was an extensive survey among the staff of all its companies. The Group thus provided all its 469 members of staff with fulfilling and stable employment in a promising field, in the regions and its Prague headquarters.

The Board of Directors will continue to bring forward projects in the field of sustainable development using a number of innovations and new technologies. This is part of the strategy for the further growth and expansion of the MVV Energie CZ group on the Czech energy market.

Financial report

The company MVV Energie CZ a.s. achieved a profit before tax of CZK 166.7 million in the 2020–2021 financial year. Compared to the previous year, there was an increase of more than CZK 16.5 million, which was mainly due to higher income from shares in controlled entities (by CZK 20 million).

The company generated an operating loss of CZK 35 million. Higher costs were associated mainly with financial and economic consulting related to the initiation and development of new business models of the entire MVV Energie CZ group. The operating costs connected with the implementation of the necessary measures against the spread of the coronavirus pandemic and new IT equipment were also higher.

The company has also invested in a new MVV online customer platform. The aim is to enable customers in the Smart House Vision projects to manage their supply point in a modern and easy way and to supervise electricity consumption. The new MVV online platform will be gradually used within EPC (energy performance contracting) projects and also by the business team of MVV Energie CZ group.

The increased personnel costs are related to the expansion of the energy services division. These will be expressed in the near future by higher sales (revenues) of this department. After all, compared to the previous period, revenues from the sale of services increased by approximately CZK 19 million, with the main influence being revenues from EPC projects.

Two significant EPC projects were completed in the period under review. In the first case, there was a project for the Ústí nad Labem region implemented in a total of ten buildings, including secondary schools and social services facilities. The second was a project of energy savings for the University of Ústí nad Labem. At the same time, implementation of the project in the building of the District Court in Pilsen and expansion of the existing project in the SMOSK administrative center in Prague began. The profit from these work-in-progress activities will affect the economic result in the next period.

Lower interest income from deposits with banks was also reflected in the financial result without the influence of income from shares in controlled entities. This was mainly due to lower interest rates on the financial markets.

There was also space for innovations in the field of financial management. To make efficient use of funds within the MVV Energie CZ group, the company started using the liquidity management system in the autumn of 2020. The companies of the Group participated in so-called cash-pooling and the parent company MVV Energie CZ a.s. provided two long-term loans to its subsidiaries. Account balances, including interest rates, are mentioned in the notes to the financial statements.

Despite a turbulent period of the Czech energy market, which was already affected by a sharp rise in commodity costs at the end of 2020–2021 and will continue to be reflected in the overall performance of all entities operating in the Czech Republic, the results demonstrate the current stability of MVV Energie CZ a.s. The total assets increased by CZK 347 million to CZK 3 billion, with almost everything relating to cash-pooling items.

During the fiscal year 2021 the Supervisory Board met twice – on 18 December 2020 (by video conference) and 15 July 2021 (by video conference).

The Supervisory Board was regularly informed about the company's activities, its financial situation, and other substantial matters, including those relating to the other companies that make up MVV Energie CZ Group. Among other things, the Supervisory Board:

- Took note of the financial statement of MVV Energie CZ a.s. for the fiscal year 2020 and recommended its approval to the sole shareholder.
- Approved the financial plan of the MVV Energie CZ Group for the fiscal year 2021 and recommended its approval
 to the sole shareholder.
- Recommended approval of the auditor for the fiscal year 2021 to the sole shareholder.

In accordance with the law, the Supervisory Board reviewed the regular final accounts and consolidated final accounts as of 30 September 2021. It concluded that the accounting records and books had been maintained in accordance with accounting regulations and the final accounts truly and fairly reflect the financial situation of MVV Energie CZ a.s., respectively the consolidated unit of MVV Energie CZ a.s. as of 30 September 2021.

The audit of the financial statements was conducted by PricewaterhouseCoopers Audit, s.r.o., who confirmed in their audit report that financial statements were prepared in accordance with Czech accounting legislation, and they provide true and fair view of the financial position of MVV Energie CZ a.s. as at 30 September 2021.

The Supervisory Board also reviewed the proposal of the Board of Directors with regards to the distribution of profits earned in the financial year 2020.

Based on the above, the Supervisory Board recommended the final accounts for financial year 2021 to be approved by the sole shareholder and accepted the proposal of the Board of Directors for the distribution of profits.

The Supervisory Board reviewed the organizational structure and results of the MVV Group-wide Compliance Management System as implemented by MVV Energie CZ subgroup in its meeting on 18 December 2020 with no findings.

The Supervisory Board would hereby like to thank the Board of Directors and all employees for their continued efforts and commitment throughout the financial year 2021.

Our opinion

In our opinion, the financial statements give a true and fair view of the financial position of MVV Energie CZ a.s., with its registered office at Kačírkova 982/4, Praha 5 (the "Company") as at 30 September 2021, of the Company's financial performance and cash flows for the year ended 30 September 2021 in accordance with Czech accounting legislation.

Notes to the financial statements

1. General information

1.1. Introductory information about the Company

MVV Energie CZ a.s. ("the Company") was incorporated on 6 October 1993 and has its registered office at Kačírkova 982/4, 158 00 Prague 5 – Jinonice. The Company is registered in the Commercial Register under file number Section B, insert 14942 kept by the Municipal Court in Prague. The identification number of the Company is 49685490. The main business activities of the holding company are services in the field of technical and economic advisory and the implementation of energy saving projects.

The Company updated its Articles of Association that are now fully governed by the new Business Corporations Act.

This fact became effective as at the date of its registration into the Commercial Register, specifically on 15 October 2015.

The Company is not a shareholder having unlimited liability in any undertaking.

Similarly to the prior year, in the year ended 30 September 2021 the Company's business was affected by the COVID-19 pandemic. Due to restrictive measures imposed by the government during the pandemic, the Company failed to achieve all planned revenues, especially in the sale of energy services. In the following period, the Company expects growth in revenues from the sale of energy services and the expansion of the Energy Services Division.

2. Accounting policies

2.1. Basis of preparation

The financial statements have been prepared in accordance with Generally Accepted Accounting Principles in the Czech Republic relevant for medium-sized companies and have been prepared under the historical cost convention except as disclosed below.

Investments in subsidiaries are valued by the equity method.

Management has considered the impact of the novel coronavirus causing the COVID-19 disease when assessing the valuation of assets and liabilities and going concern assumptions.

2.2. Investments in subsidiaries

Investments in subsidiaries represent ownership interests in enterprises that are controlled by the Company ("the subsidiary").

Investments in subsidiaries are accounted for by the equity method of accounting. Under this method, the investment is initially recorded at cost and the carrying amount is increased or decreased to recognise the investor's share of the equity of the subsidiary as at the balance sheet date. Revaluation of investment by using the equity method of accounting is recorded through the Company's equity.

2.3. Inventories

Purchased inventories are stated at the lower of cost and net realizable value. Cost includes all costs related with its acquisition (mainly transport costs, customs duty, etc.). The actual costs method is applied for all disposals.

Inventories generated from own production, i.e., work-in-progress and finished goods, are stated at the lower of production cost and estimated net realizable value. Production costs include direct and indirect materials, direct and indirect wages and production overheads.

2.4. Receivables

Receivables are stated at nominal value less a provision for doubtful accounts. A provision for doubtful accounts is created on the basis of an ageing analysis and individual evaluation of the creditworthiness of the customers. Receivables from related parties have not been provided for.

2.5. Foreign currency translation

Transactions denominated in a foreign currency are translated and recorded at the rate of exchange ruling as at the transaction date. In case of purchase or sale of foreign currency for Czech crowns, the exchange rate for which these values were purchased or sold is used.

Cash, receivables and liabilities balances denominated in foreign currencies have been translated at the exchange rate published by the Czech National Bank as at the balance sheet date. All exchange gains and losses on cash, receivables and liabilities balances are recorded in the income statement.

2.6. Changes of accounting policies and corrections of prior period errors

Changes to accounting policies (inclusive of deferred tax impact) and corrections of errors arising from incorrect accounting or unrecorded expenses and income in prior periods, if material, are recorded on financial statements line Restatements of retained earnings.

2.7. Provisions

The Company recognises provisions to cover its obligations or expenses, when the nature of the obligations or expenses is clearly defined and it is probable or certain as at the balance sheet date that they will be incurred, yet their precise amount or timing is not known. The provision recognised as at the balance sheet date represents the best estimate of expenses that will be probably incurred, or the amount of liability that is required for their settlement.

2.8. Revenue recognition

Sales are recognised upon the delivery of products and customer acceptance and are stated net of discounts and value added tax.

Sales are recognised as at the date the services are rendered and are stated net of discounts and value added tax.

2.9. Related parties

The Company's related parties are considered to be the following:

- · parties, which directly or indirectly control the Company, their subsidiaries,
- parties, which have directly or indirectly significant influence on the Company,
- members of the Company's or parent company's statutory and supervisory boards and management and parties close to such members, including entities in which they have a controlling or significant influence,
- subsidiaries.

Material transactions and outstanding balances with related parties are disclosed in Note 10.

2.10. Interest expense

All borrowing costs are expensed.

2.11. Deferred tax

Deferred tax is recognised on all temporary differences between the carrying amount of an asset or liability in the balance sheet and its tax base. Deferred tax asset is recognised if it is probable that sufficient future taxable profit will be available against which the asset can be utilised.

2.12. Employment benefits

The Company does not recognise a provision relating to untaken holidays due to its immateriality.

The Company recognises a provision relating to rewards and bonuses of employees.

Regular contributions are made to the state to fund the national pension plan. The Company also provides contributions to defined contribution plans operated by independent pension funds.

2.13. Cash-flow statement

The Company has prepared a Cash-flow statement using the indirect method. Cash equivalents represent short-term liquid investments, which are readily convertible for a known amount of cash.

The Company uses so-called cash-pooling within the group. Receivables (liabilities) that arise from cash-pooling are presented in the Cash-flow statement as part of the item Cash and Cash equivalents. If the liability arising from cash-pooling represents a form of financing, then it is not presented in the Cash-flow statement as part of the item Cash and Cash equivalents.

2.14. Subsequent events

The effects of events which occurred between the balance sheet date and the date of preparation of the financial statements are recognised in the financial statements in the case that these events provide further evidence of conditions that existed as at the balance sheet date.

Where significant events occur subsequent to the balance sheet date but prior to the preparation of the financial statements which are indicative of conditions that arose subsequent to the balance sheet date, the effects of these events are disclosed, but are not themselves recognised in the financial statements.

4. Inventories

Inventories amounting to CZK 5,160 thousand as at 30 September 2021 represent work-in-progress related to EPC projects (as at 30 September 2020: CZK 36,751 thousand).

No impairment was created to inventories as at 30 September 2021 and as at 30 September 2020.

5. Receivables

Overdue receivables as at 30 September 2021 amounted to CZK 138 thousand (as at 30 September 2020: 5,272 thousand).

Impairment of receivables as at 30 September 2021 amounted to CZK 268 thousand (as at 30 September 2020: CZK 268 thousand).

Unsettled receivables have not been covered by guarantees. As at 30 September 2021, receivables due after more than 5 years amounted to CZK 650 thousand (as at 30 September 2020: CZK 928 thousand).

The Company has no receivables nor provided any guarantees which are not included in the balance sheet.

6. Equity

The Company is fully owned by MVV Energie AG, incorporated in Germany. MVV Energie AG is also the parent company of the whole group MVV Energie CZ.

The Company is a part of a single consolidation unit, whose parent company is MVV Energie AG. The consolidated financial statements can be obtained at headquarters of MVV Energie AG at D-68159 Mannheim, Luisenring 49, Germany.

The Company is fully governed by the new Business Corporations Act (see Note 1) and used the option not to create a reserve fund. This fact is further enabled by the Articles of Associations of the Company.

The Board of Directors prepared the financial statements and decided about the allocation of profit earned for the year ended 30 September 2020, which was submitted to the sole shareholder for approval on 18 December 2020. The sole shareholder approved the financial statements for the year ended 30 September 2020 and decided about the allocation of the profit earned for the year ended 30 September 2020 in the amount of CZK 150,223 thousand to retained earnings.

The sole shareholder decided about payment of the profit share in the amount of CZK 190 million on 18 December 2020.

Until the date of preparation of these financial statements, the Company has not proposed distribution of the profit earned for the year ended 30 September 2021.

7. Provisions

Other provisions as at 30 September 2021 amounted to CZK 4,004 thousand (as at 30 September 2020 CZK 5,634 thousand). Provisions mostly consist of provisions for employees' wages and bonuses.

8. Payables, commitments and contingent liabilities

Payables have not been secured against any assets of the Company and are not due after more than 5 years.

Total non-cancellable future commitments in respect of operating leases (not recorded in the balance sheet) from the lease agreement of the Company's registered office, for rent and related services amounted to CZK 15,927 thousand as at 30 September 2021 (as at 30 September 2020: CZK 18,488 thousand).

The Company had bank guarantees issued for operational purposes as at 30 September 2021 in amount of CZK 5,768 thousand (as at 30 September 2020: CZK 3,106 thousand).

As at 30 September 2021 the Company has contingent liability in the amount of CZK 12,355 thousand (as at 30 September 2020: CZK 15,808 thousand) (without interest) due to a ceded receivable with maturity to 31 December 2024.

9. Bank loans and other borrowings

The Company has no bank loans. Loans to related parties are described in Note 10. Related party transactions.

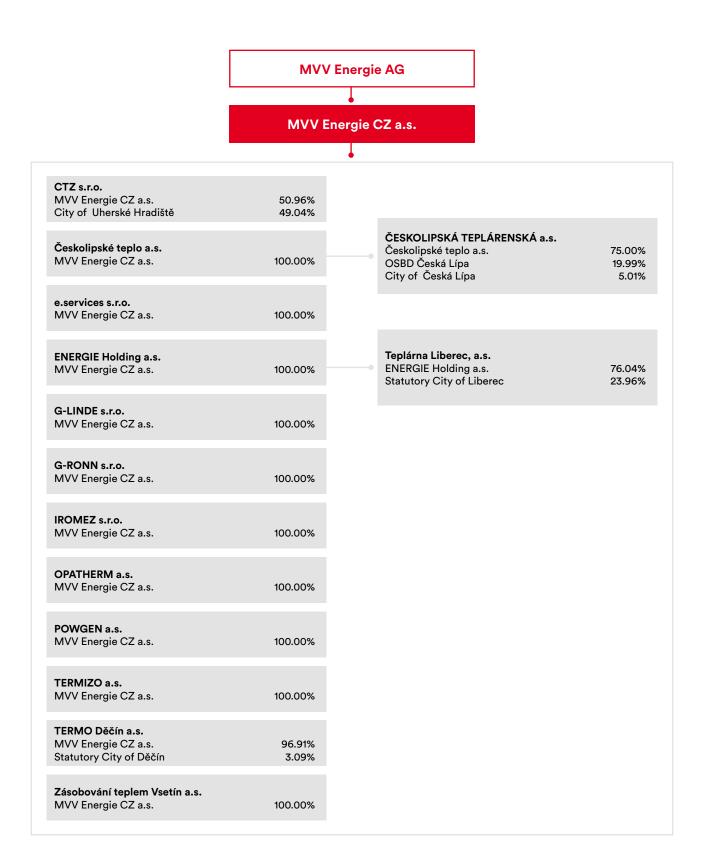

Events after the reporting period

Due to the enormous growth of fuel prices on the energy market in the autumn of 2021, especially natural gas, the company expects negative impacts in the following year both in the economic result and in the area of cash flow.

The company MVV Energie CZ a.s. issued guarantees for the fulfillment of obligations arising from gas supply contracts in the total amount of EUR 24,250 thousand (CZK 616,799 thousand; CNB exchange rate as on 9 December 2021). At the same time, the company MVV Energie CZ a.s. received guarantees of the same amount from its parent company MVV Energie AG.

Apart from the events above, no other events have occurred subsequent to year-end that would have a material impact on the financial statements as of 30 September 2021 or on the annual report for the fiscal year 2020–2021.
